Youth Services: Health Connected provides classroom-based instruction on puberty and sexual health to schools and districts in the Bay Area. During the 2024-2025 school year, Health Connected served 13838 students through the Youth Services Program.

Provider Services: Health Connected provides teacher training and technical assistance for schools, districts, and community-based organizations seeking to implement puberty education or sexual health instruction for their students. Health Connected trained 673 teachers during the 2024-2025 school year reaching an estimated 20,190 students across California.

During the 2024-2025 school year, Health Connected served 4,316 parents across California through the Parent Services Program.
