MANNA ESTIMATES THE WEIGHT OF FOOD DONATIONS AS IT IS RECEIVED AND DISTRIBUTES FOOD TO FAMILIES AND OTHER ORGANIZATIONS. THE NUMBER OF FAMILIES MANNA DISTRIBUTES TO IS TRACKED ON A DAILY BASIS. USING THE \$1.70 POUND VALUE, THE VALUE OF ITEMS CONTRIBUTED (\$617,716) WOULD EQUATE TO 363,362 POUNDS OF FOOD INVENTORY CONTRIBUTED. MANNA SERVED 4,593 FAMILIES WITH ALL VISITS OF 13,779 TO OUR FOOD PANTRY DURING THE FISCAL YEAR ENDED FEBRUARY 28, 2025.
